The focus of post-acute care has begun, and will continue, to shift towards value over volume. This does not mean that less therapy is indicated. However, what a therapist focuses on when evaluating and setting the plan of care will be even more critical in this new environment. This course will focus on providing evidence-based tests and measures to use for evaluations, review frameworks for effective care planning to reduce re-hospitalizations and provide evidence-based interventions for optimal outcomes in treating the complex older adult in the SNF and Home Health settings.
