She is on the Board of Directors for NDTA as well as the conference planning committee, the Centers of Excellence committee, the Instructor Group Executive committee and writes for the NDTA Network. She presents continuing education courses on NDT, Therapeutic Taping in Pediatrics and Functional Exercise and Strengthening for the Child with Neurological Impairments both nationally and internationally.

About this Course

Treating children with severe physical impairments, with or without cognitive impairments presents unique challenges. This course is designed for physical and occupational therapists who work with this population and want to expand their skills. We will explore the challenges of working in various settings and how to set treatment priorities for each setting. We will discuss realistic, functional goal setting and how to work to make goals achievable. We will explore dosing for this population who require lifelong service and how to build in carry over when not in active treatment. Practical labs working with an adult partner and doll will reinforce treatment concepts.

- ② The evaluation process
- ③ Functional goal setting
- ④ Treatment interventions based on system impairments
- ⑤ Major challenges that occur across the lifespan

- ⑤ The student will be able to demonstrate three treatment strategies for treatment of the child with severe impairments
